Say No to Gene Patents Campaign

Cancer Voices continues to call for an amendment to the Patents Act 1990to remove the ability to patent human genetic material. For CVA, Sally Crossing was invited to address the Coalition Backbench Policy Committee on 24 June – the last sitting week of Parliament. Her address, posted on Croakey 4 July, was a good opportunity to discuss the impact of the very positive decision against patenting human genes by the US Supreme Court on 13 June. CVA members will be attending the Australian Federal Court (full Bench) hearing of the Appeal against the February decision, on 7-8 August in Sydney.

Cancer Voices has played an active advocacy role on this issue over the last six months and is pleased that our formal call for a full review has been expedited by Minister Plibersek, Minister for Health. The aim of the Review is "to maximize the benefits consumers receive from chemotherapy infusions by ensuring efficient and effective clinical processes and appropriate funding arrangements for the preparation and supply of those infusions". Cancer Voices is making a formal submission to the Review. We are working with Consumers Health Forum of Australia which has been engaged to consult directly with consumers and consumer groups. Contact us about opportunities to contribute, or you can do so directly to the Review by end July. The Review will report to the Minister by October.
